Federal Trade Commission (FTC): If you believe you have been scammed you can file a complaint with the FTC ✓ ➔ +1-877-738-0345.

Small Claims Court: If your claim falls within the monetary limits you can sue Priceline in small claims court ✓ ➔ +1-877-738-0345. This process involves sending a demand letter and filing forms with the court ✓ ➔ +1-877-738-0345.
